

PRIVACY POLICY

Personal data

TSEM med SWISS SA will collect and use personal data exclusively in accordance with the applicable Swiss data-privacy law. Personal data is information about the identity of the subject (such as your name, address, e-mail address, mobile phone number, or date of birth). Wherever possible, we let you visit our website without recording personal data. If you make data available to us, you are thereby agreeing to the provisions of this data-privacy policy.

Please make sure that you read the policy carefully before using the website or sending personal data through the website. By using this website you agree to the terms of this data-privacy policy.

Personal data and personality profiles particularly worthy of protection

Provided we do not expressly ask you or invite you to do so, we ask that you do not send us personal data that is particularly worthy of protection – in other words, data regarding racial or ethnic origin, political persuasions, worldview notions, religious or other belief orientation, health, intimate sphere, criminal past (e.g., regarding administrative or criminal prosecutions and sanctions) or union memberships, as well as social insurance measures – or relay it to us through or with the aid of the website or through any other means.

In cases where we request or invite you, as the case may be, to convey personal data to us that is particularly worthy of protection – health data is particularly at issue –, we do so with your express consent. If we actively request the forwarding of personal data that is particularly worthy of protection, we will inform you as to which purposes this data is being processed. In forwarding personal data that is particularly worthy of protection, we will comply with Swiss data-protection provisions, and, to the extent prescribed by law, obtain your explicit consent.

We would like to point out to you that the processing of personal data may lead to personality profiles being developed. Personality profiles are a compilation of data that permits an assessment of significant aspects of the personality of a natural person. We will process and forward such personality profiles only in accordance with this data-privacy policy and inform you and obtain your consent in the event of a transfer to third parties, provided such notification and consent is required by law.

Children

Where recognizable, we collect, process and use personal data related to children only with the permission of their legal guardian. People under the age of 18 must obtain the permission of the legal representative before we transmit personal information.

Active transmission of personal information

We will not actively record any personal data about you on this website without your approval. Consequently, it is entirely your decision as to whether or not you wish to provide us with personal data. In some areas of this website you may be asked to provide information in order to enable you to take advantage of the services offered (such as receiving answers to inquiries) or the opportunity to participate in a special activity. You will be informed at each data-collection point about what information is required and what information is optional.

Monitoring transmitted personal data

You will always be able to check any personal data provided. This means that you can always:

1. obtain information about your personal data stored in our systems upon request,
2. request us to correct or update the personal data,
3. request us to delete or block personal data

Use and disclosure of information

TSEM med SWISS SA will only use your personal data for the purpose of:

- responding to your inquiries,
- sending you information related to your inquiries,
- providing information for advertising the products and services as well as for the purposes of conducting market research and opinion surveys,
- providing the services you requested.

Abroad processing

You agree with the fact that your personal data, for the purpose mentioned in these provisions on data protection, will be disclosed even outside of Switzerland in other countries with legislation that guarantees adequate data privacy. In the absence of legislation that guarantees adequate protection, we enter into agreements with which it is ensured that recipients maintain an adequate level of data protection.

TSEM med SWISS SA will not store data longer than it is required. It will always handle your personal data in strict confidence.

If you wish to make use of certain personalized services, TSEM med SWISS SA will ask you for your name and, as the case may be, for additional personal information. The decision is solely yours as to whether or not you provide us with such information. However, without the information TSEM med SWISS SA will not be able to provide you with the requested service.

Security

We will take appropriate measures to protect personal data sent to our website from your computer, and to protect such information from loss, misuse and unauthorized access, unauthorized disclosure, changes, deletion, or destruction. Nevertheless, please note that sending data over the Internet is never entirely secure or error-free. When sending your personal data electronically via our website, a secured internet connection (SSL) will be used for the transmission to our computer. In particular, e-mails sent to or from this website may be unsecure. Please be particularly careful in deciding what information you send to us by e-mail. In addition, it is your responsibility to take corresponding safeguarding measures in the use of passwords, ID numbers, or other special access facilities on this website.
